A Letter From The President

As PPERRIA president I am urgently asking all of the residents of Prospect Park/East River Road to get involved in the process of decision making that is now taking place in and around our community. There are 4 items in particular that are on the agenda.

1) A planning study is being compiled by the city and county for any future changes in land use around the Central Transit Corridor (University Avenue) and the SEMI Industrial Area.

Changes in land use along University Avenue may determine whether or not Prospect Park (including 4th St. SE) remains a viable low density residential neighborhood. We must be actively involved in this study.

2) We will have both as a community and as individuals, the opportunity to make comments and have input on the Environmental Impact Study (EIS) for the LRT planning process for the Central Corridor.

We know our community better then any consultant. We must make sure that the EIS is accurate and that our community will not be sacrificed for transit (as it was for the building of I-94).

3) The kick-off meeting for NRP Phase II will be held October 13.

NRP Phase I enabled us to complete the historic survey that qualifies Prospect Park for the National Register of Historic Districts, giving us protections and considerations that are guaranteed by federal law. We need to fund the actual application to the Register so that future generations will be able to enjoy our community as much as we do now.

4) There are also some major building plans in progress that will have significant impact on our neighborhood, including the

University of Minnesota's intention to possibly tear down several blocks of student housing in the area near the University Hospital so they can build more medical facilities. And apparently the Hubbard Corporation is developing a plan to build high-density housing on the property to the north of KSTP. How will these projects affect our neighborhood? And what can we do to have a say in the planning process as a whole?

I know that many of you think, "Why should I get involved because they will do whatever they want anyway?" But you are wrong. And I have seen over and over how a community or a group with a goal or issue can make a big difference as to what goes on in their neighborhood.

In order to prove this to you, I would like to tell you a few stories of events I have witnessed first hand that will demonstrate the power you have if you would only use it. I will start with the Midway Area in St. Paul. A planning process similar to the one proposed for us began a couple of years ago and the Midway Chamber of Commerce wanted to have the single family housing zoning changed to high density. In response, the home owners came out by the hundreds to meetings and focus group get-togethers and the message was clear; Leave our homes alone. The proposal by the very powerful Midway Chamber for rezoning was not included in the new plan.

The second event also took place in St. Paul when St. Thomas College announced it wanted to tear down 12 single family houses they owned along Summit Avenue in order to build more student housing and class rooms. The problem for the College was that some 20 years ago the Community Council around St. Thomas worked with the Summit Avenue Preservation group to have all of Summit designated a historic district and under city law no building could be demolished without the approval of the City Council. The project was in limbo for five years until just last month when a compromise was reached whereby the College agreed to rehab 30 homes that had been used as student rentals and then sell them as single family dwellings with a covenant that they could not be used as

rental properties in the future. For this concession the College was allowed to take down 6 of the 12 homes with the stipulation that the architecture of the new buildings would be the same style and materials as the original campus buildings facing Summit.

The last of the three events I would like to share with you is about a community in Minneapolis that had the foresight to begin a plan to preserve and enhance its commonwealth assets very early on. It was this early planning that empowered them to have amended a large industrial planning project so that it would no longer threaten some 40 residential homes. They were able to foil the possible plans to demolish a significant public building that had been a centerpiece of their community for over 100 years. All this while they added an additional 50 or so new homes.

The name of this neighborhood is Prospect Park East River Road, the industrial planning project was the SEMI, and the public building is Pratt. The empowerment of which I speak came about because of goals and objectives put forth in their NRP Phase I.

To close I would like to ask you to get involved in setting the future course of your neighborhood. Remember that decisions are made by those who show up.

Motion

A motion will be made to amend the By Laws of the Prospect Park East River Road Improvement Association, Article III B as follows:

Any natural person over [17] <u>18</u> years of age is eligible for membership in PPERRIA if the [permanent and primary] <u>registered voting</u> residence of the person is within the boundaries of PPERRIA. The person must complete and submit to the Executive Committee the adopted PPERRIA membership application.

(The bracketed language will be deleted, and the underlined language added.

Resolution

A resolution will be proposed as follows:

BE IT RESOLVED that:

(1) Separate funds shall be maintained for community events, the Garden Club, the Historic District, and for professional expenses as follows:

Community Events in the Community Events Fund

Garden Club in the Garden Club Fund

Historic District in the Historic District Fund

Professional Expenses in the Professional Expenses Fund

Choir in the Choir Trust Fund

(2) Thefunds collected by the Prospect Park History Committee and for the neighborhood cleanup shall be maintained in the general fund.

- (3) Annual budgeting and accounting for any activities involving separate funds presumes that funds are spent first from funds received or collected by the responsible committee and only after exhausting those funds from funmds budgeted from the PPERRIA general fund.
- (4) The activities and budget of each committee maintaining separate funds must be reviewed each year by the Executive Committee prior to the presentation of the budget for the following year to determine whether the budget must include returning any money in separate funds to the general fun.

Minutes July 26, 2004

 The 07/26/04Prospect Park East River Road Improvement Association Inc. (PPERRIA)Board of Directors (BOD)/Membership/Neighborhood (B/M/N) Meeting was called to order by Joe Ring, President, at 7 P.M. at the Prospect Park United Methodist Church (PPUMC) (Orlin and Malcolm Avenues S.E. Minneapolis, Minnesota 55414) A quorum of the BOD was present. Introduced were new members, first time attendees and visitors. Motion made, seconded and passed without noes: "To accept as the agenda for this meeting the agenda amended and available at this meeting."

Added were additional items to Item 5, Announcements: A) Pratt Boot Sale and Pancake Breakfast on 09/18/2004; B) Light Rail and development density; C) #8 bus and the neighborhood; D) Request for information regarding the Minic Triangle Park. See attached Item 1.

The meeting is conducted according to Robert's Rule's of Order. In addition, Joe Ring reminded all that: A) All additions and/or corrections to items that are to be included in the agenda are to be done at the time the agenda is accepted. Items proposed later are to be considered "out of order"; B) All discussion, points of order, etc., occur before the vote is taken to accept or reject the motion. Continued action(s) on the motion are considered "out of order"; C) All motions, amendments, etc., are to be received in writing by the chair and secretary before any action taken is included in the minutes other than a reference in the minutes; D) The "Announcement" item is "Point(s) of Information" without action and/or comments at this meeting. E) Any proposed agenda changes after the agenda has been approved are subject to a motion by those attending this meeting: e.g., additional time.

Attached Items to the minutes were available at this meeting. There were no additional items added to this agenda.

Note: Minneapolis Council Member Paul Zerby was in attendance at this meeting, as he lives in this neighborhood. He abstained from any votes; except Item 3, Pratt School/ Building Position Paper.

2) Motion made by Dick Kain, seconded by Bill Kahn and passed without noes: "That the amended minutes of the 06/28/04 PPERRIA B/M/N Meeting published in the PPERRIA 06/2004 Newsletter be approved." See attached Item 2. The secretary received amendments prior to this meeting regarding: A) Item 2, "Rachel Ramadhyani," maker of the motion and "Chris Phillips," seconding the motion; B) Item 6. added start of the sentence was "All were...." Deleted was "Joyce Barta" and "all".

- 3) Motion made by Betts Zerby, seconded by Steve Banks and passed without noes: "That PPERRIA supports the position and analysis paper that has been prepared by the neighborhood 'Save Pratt Committee' be forwarded to Minneapolis Public Schools (MPS) Superintendent Thandiwe Peebles, with copies to the members of the Minneapolis Public School Board of Education." Pratt should remain in the Pratt Building as part of the Pratt/Tuttle school; A) budget analysis, at full enrollment, shows Pratt will operate at a surplus; B) The outcomes from Pratt warrant no change of site; C) Pratt has remarkable community support; D) Pratt has a unique partnership with Tuttle School and Community Education: D) Pratt demonstrates its success of the community school model; E) By undermining a superb partnership between MPS and the Southeast Community, closing Pratt will hurt Tuttle school and drive many students out of MPS altogether. Betts Zerby reviewed the document and the process. The cover letter will be signed by the presidents of the Pratt Council, Pratt PTO, Save Pratt Committee and PPERRIA. The Como Neighborhood Association also supports the position. There is included a five page discussion of the above points as well as a nine page analysis of the Pratt School Budget and physical plan. Included is a statement of the alternate school options for the Pratt Building:. F) A MPS sponsored Charter School; G) An independent Charter School; H) An independent Charter school with neighborhood responsibility for the Pratt building; I) An independent Charter school with the neighborhood having ownership of the Pratt Building. It is an assumption that there will be some type of elementary school in the neighborhood. Also all of the options include continued operation of Community Education in the Pratt Building. See attached Item 3.
- 4) Motion made by Bill Kahn, seconded by Ross Carlson and passed with some noes: "That PPERRIA table the issue of the proposed University of Minnesota (UM) Crew Boat House located on the Minneapolis Park Board property at East River Flats Park adjacent to the Mississippi River for further information." An earlier motion regarding this issue was being discussed when the motion to table was made. A motion to table takes precedence and is to be, without debate, voted on immediately. Representatives from the University of Minnesota, Joel Maturi (Athletic Director), Jan Morlock (Community Relations), Regina Sullivan (Project Coordinator) and Orin Miller (Planning) reviewed the project. Several years ago there was an earlier Crew Boat House project on the same site. The UM imposed a moratorium on building additional athletic facilities which delayed the project until now. The Minneapolis Park Board will make the yes/no decision regarding the facility as it will be built on their property. The UM Athletic Department will be solely responsible for obtaining non-public funding for the project. The issue regarding the earlier proposal is the same as now, "The use of Minneapolis Park Board Property other than as open space." The East River Park is part of a public open space along the east side of the Mississippi River within the metro area, much of which is currently in use as a park. The PPERRIA Zoning and Planning Committee has been presented the current proposal and has recommend that there be additional information and discussion. An extensive discussion of the proposal occurred. Comments: A) The central issue is of the area being "Natural-Benefit the Many" or "Managed-Benefit the Few ?"; B) Is the area that has become Minneapolis Park Board Property to be used other than for open land?; C) Are a few individuals, approximately 100 UM Crew members, rather than the "public" to use the site that the proposed Crew Boat House is to be built on?; D) The part of the east Mississippi River that is in public ownership has undergone many changes that have increased the use of the area by the public, e.g., construction of a pathway and walking bridge system, clearing of vegetation, construction of public roadways and stairways to the area. E) The proposed project is to be on the site of the earlier UM Showboat and will use the existing concert apron into the Mississippi River; F) The river portion between the Lake

Street and University Avenue bridges is considered one of the premier crew courses in the country; G) There exists on the west river bank at the Lake Street Bridge, the Minneapolis Rowing Club facility: H) The proposed building is to be two stories of textured concrete construction with boat storage on the first floor and training/locker facilities on the second floor. Crew members who are not on the river use the dry land training facilities: I) The UM will construct a separate public toilet and water facility; J) Parking will be provided by the Minneapolis Park Board, who are reviewing changes within the entire park; K) The UM Athletic Department proposes to have staff provide services available to the public; L) It was mentioned that these types of outreach services were usually the first to be cut during budget decisions; M) What will the UM give to the public for use of the site?; N) The proposal came from the UM Athletic Department several years ago and now again; O) Undecided is having the site available for private individual boat storage; P) There were questions about the design review process and the current design; Q) The building is below the tree line and the sight line from Coffman Union; R) The building is above the 100 year flood line but the whole park is on the existing flood plain; S) The current Women's Varsity Crew Team and the Men's Club Crew Team operate out of questionable facilities: T) There is proposed a public viewing deck on the top of the proposed building; U) Any utilities needed are already on the site and would only require hookups: V) The building would be under the Minneapolis Park Board jurisdiction.

- 5) Announcements: A) Tuesday 08/03/2004 is the National Night Out. See PPERRIA 06/20004 Newsletter; B) The city and county has agreed on 09/11/04 as the neighborhood cleanup day. As per last year, the pickup will be in the A.M. of items that are not picked up in the weekly city trash pick up; brush, concrete and metal; and the county will have a hazardous waste drop off along the I-94 wall on Arthur Avenue S.E. between Melbourne and Arthur Avenues S.E. The city now charges for a truck and driver. A sign-up sheet was circulated; C) John Holmquist reminded all that 09/18/2004 is the Pratt Boot Sale and Pancake Breakfast. D) Joe Ring referred all to statement by Ronald Reagan Federal Transit Administration Director Jennifer L. Dorn at the opening of the Hiawatha LRT line: "...and how zoning policies can make for a dense environment that will enhance ridership. We also think it's important to have even more support for park-and ride lots...." See attached Item 5. The relevant words are "dense" and "park-and-ride lots" as to their impact on any LRT Stations located in or adjacent to this neighborhood. Motion made by Dean Lund and seconded by Susan Larson Fleming and passed without noes: "That at the 09/27/2004 PPERRIA B/M/N meeting there be an Information/ Question/Answer agenda item regarding this issue": E) Motion made by Bill Kahn and seconded by John Holmquist and passed without noes: "That PPERRIA supports the letter regarding the #8 bus." Dorothy Marden reviewed the issue. Last year she was active in the continuation of the #8 bus service within the neighborhood and its connection to downtown Minneapolis. With the completion of the Franklin Avenue LRT station, there have been changes in the #8 bus operation that in her opinion have resulted in a decline of ridership and to expect further containment of service. She recommends a change in the layover area at the Franklin Avenue LRT station, a return to east movement of the bus to Franklin Avenue S.E. and a one morning and evening trip each way along the East River Parkway; F) Steve Cross requested any information anyone may have regarding the actions several years ago regarding the Minic Trangle Park, East River Parkway/Franklin Avenue/27th Avenue S.E., and the Minneapolis Park Board in the proposed installation of a park identification sign at the park. - 6) Phil Anderson, Zoning Committee member, reviewed the items that have come before the committee; A) The issue of a proposed CVS Pharmacy at 25th and University

Avenues S.E. continues. CVS is requesting a zoning change to permit suburban type building and parking with drive-in service. The city planner is not recommending the zoning change in that it would not be in compliance with the existing Minneapolis Comprehensive Plan nor the zoning of the area. One problem is the questionable changes made during the previous council member's term to accommodate the developers of the University Village site, across the street from the proposed CVS site. The issue now goes to the City Zoning and Planning Committee and then to the full city council; B) The new owner of 625 Erie Street S.E. needs the expansion of the existing non conforming use of two resident structures on one lot so he can expand and update the existing structures. This is an early example of building a separate living structure for relatives on the same lot of your own living structure. Existing examples of this were grandparented in when the zoning law was changed not to allow such on single building lots. The city planners have recommended the variance needed. The issue now goes to the city Zoning/ Planning Committee and the full council.
